### Meeting Notes:

Kevin reported that the Plant Sale realized just over \$9,000. on its last day, which was this past Saturday. Overall, for all (3) days sales totaled \$22,224 and our 1/3<sup>rd</sup> share was \$7,408. Although the results were somewhat less than recent years Kevin thanked everyone in our Club that supported this most important fundraiser by generously giving of their time in the terribly cold and rainy conditions that prevailed most of the (3) days.

Bylaws will be voted on at a Board Meeting scheduled for May 24. Our 501c(3) filing status is still pending. Paul Pace reported on possible Club involvement in The Town of Suffield "Island Project". On the basis of a Town Meeting he recently attended Paul believes their design concept doesn't work due to lack of space and recommended that Suffield Rotary should pass for now.

One of Suffield Rotary Club's own, Glenn Spaulding, gave an interesting presentation on high altitude jet flying. During Glenn's civilian and military life over a span of decades he flew many different planes including the F100 pictured to the left. He piloted the F100 to an altitude of 68,000 feet traveling at 1,200MPH(MACH 1.4) or 1.4 times the speed of sound! We learned the meaning of such terms as "Sidewinder," "compressor stall," and "barn doors." Prior to his retirement from the military in 1988, Glen traveled at altitudes of up to 75,000 feet. It was very obvious from Glenn's demeanor that he treasures all the years of fond memories from his high altitude aircraft flying experiences! Tom M.
